2. The Tendered materials may be inspected at concerned production centres, Godown at Tiptur during office hours. The list of Production Centres along with the disposal item details is enclosed in **Annexure-1.**
3. Last Date and Time for Receipt of the Tender is **19.08.2017 upto 4.00 P.M.**
4. The date and time of opening of tender is **21.08.2017 at 11.30 A.M. in the Corporate office** in the presence of such tenderers/their authorised representatives. Only one person per tender is permitted to be present.
5. No tender with corrections shall be considered as valid unless such corrections are attested by the tenderer/authorised person. The tender should be neatly written as given in the bid format.
6. Successful Bidder shall deposit Rs.10,000/- as Security Deposit in favour of K.S.C.D.C. Ltd., Bangalore from the date of intimation.

7. The Security Deposit of the successful tenderer will be retained until, the Tenderer shifts all the tendered materials from the concerned production centres etc.
8. The rate once quoted cannot be altered or modified under any circumstances.
9. The rate quoted by the tenderer should be firm and binding for ex-factory.
10. The rate should be quoted both in figures as well as in words in **Schedule –I** i.e. **Bid Form**.
11. The successful tenderer has to lift the tendered materials within 15 days from the date of receipt of awarding of order from the respective production units.
12. After opening the Tenders, the Committee appointed by the Managing Director will evaluate the tenders for acceptance.
13. The Managing Director of the Corporation reserves the right to accept any tender or right to reject all the tenders without assigning any reasons thereof and the decision of the said authority will be final.
14. The Managing Director, KSCDC Ltd., reserves the right to cancel the accepted tender and forfeit the E.M.D. amount in case of breach of any of the conditions of the tender.
