NOTICE INVITING TENDER FOR PURCHASE OF RAW MATERIALS FOR
RUBBERISED COIR PRODUCTS
(through E-procurement Portal Only)

The Managing Director, Karnataka State Coir Development Corporation Limited, Bangalore, invites tenders through **e-procurement** for purchase of Raw Materials for Rubberised coir products from the reputed **manufacturers/Suppliers** as per the specifications enclosed in **Schedule-I**. The approximate requirement indicated in **Schedule – III**.

TERMS AND CONDITIONS

1. The tender should be submitted through e-Procurement Portal as “**TENDER FOR SUPPLY OF RAW MATERIALS FOR RUBBERISED COIR PRODUCTS**” addressed to **The Managing Director, Karnataka State Coir Development Corporation Ltd, Bangalore – 560001**.
2. The tender for the bid should be as per the **specifications enclosed vide Schedule –I**.
3. Date and Time for Receipt and Submission of the Tender is **14.11.2017 to 15.01.2018 upto 3.00 P.M**
4. The date and time for opening the Tender is **16.01.2018 at 4.30 P.M.** in the presence/absence of such tenderers/their authorised representatives. Only one person per tender is permitted to be present.
5. No tender with corrections shall be considered as valid unless such corrections are attested by the tenderer/authorised person. The tender should be neatly written as given in the bid format.
6. **The Tenderer shall pay an amount of Rs.20,00,000/- (Rupees Twenty Lakh Only) as EMD through e-procurement by following modes: a)Credit Card, b)Debit Card, c)NEFT (National Electronic Fund Transfer) & d)OTC (Over the Counter ICICI Bank payment).** The E.M.D. does not carry any interest. E.M.D. will be returned to the unsuccessful tenderers within a month of finalization of the tender.

7. Tenders not supported by E.M.D. or not complete in any respect are liable for rejection.
8. The E.M.D. of the successful tenderer will be returned after completion of tender period.
9. The successful bidder should deposit a sum of Rs.20.00 lakh as Security Deposit with the Corporation by way of Demand Draft or through Bank Guarantee will be retained till tender period.
10. The rate quoted by the tenderer should be firm and binding upto **One Year from the date of Issue of Supply Order.**
11. The rate should be quoted both in figures as well as in words in **Schedule – II** which include GST, transportation and all other related expenses as applicable.
12. The indented raw materials should be delivered to the **Mattresses Manufacturing Unit at Yadavgi Industrial Estate, Mysore.** The successful tenderer has to supply the materials within 30 Days on receiving the one time supply order or indents which are part of the entire order.
13. The Tender Committee will evaluate the tenders and the Managing Director reserves the right to accept/reject the tender without assigning any reasons thereof and the decision of the said authority will be final.
14. The Corporation representatives will inspect the goods in conformity with the specifications of the products as per **Schedule – I** at the delivery site and if the supplies do not confirm to the standards, the same will be rejected at suppliers cost with penalty.
15. **The supplier should produce 3rd Party Test Reports from any Government Agency for every 500 Nos. Bare Blocks, 2000 Mts. of cloths and 2000 Mtrs. Rexine (Vinyl Coated Fabric-Drill Back) without fail.**
16. The quantity indicated in **Schedule-III** may vary marginally. **However, it may be noted that, the Corporation is expecting major orders from Government Departments and this is preparation for supplies.**
17. The successful tenderer is required to make an agreement on **Rs.200/- stamp paper pertaining to tender terms and conditions within 7 days** from the date of communication of tender acceptance in **Annexure-B**, failing which, the EMD will be forfeited.
18. Payment will be made on accepted quantity within **60** days.

19. Any damages or loss to the supplies during the transit is at the supplier`s risk.
20. The decision of the Managing Director, Karnataka State Coir Development Corporation Ltd., Bangalore is final and binding on both the parties in case of any disputes that may arise during the period of contract. However, the appeal is confined to the jurisdictional courts in Bangalore, Karnataka.
21. Suppliers shall be entirely responsible for all taxes, duties, license fees, octroi, road permits and other levies, etc. incurred until delivery of the contracted goods to FOR destination.
22. If the Tenderer is not willing to supply the material on the accepted rate for the specific period, the Corporation has the right to terminate the agreement and forfeit the EMD.
23. Further details if any, can be had from the office of the undersigned during the office hours on all the working days.
