6. <u>The Tenderer shall pay the EMD through e-procurement by following modes:</u> <u>a)Credit Card, b)Debit Card, c)NEFT (National Electronic Fund Transfer) &</u> <u>d)OTC (Over the Counter ICICI Bank payment).</u>
